Mining is also an industry which digs out mineral treasures. These two facets have been creatively blended in the logo wherein the lattice structure of the precious stone emerald has been used to form the creative design element in the logo.

The design element has a pyramid structure in the center which denotes the strong foundations on which the company has been built. The lattice structure is constructed from 5 different shades of green wherein each shade denotes one subsidiary. A circular border encloses all the design elements to denote that Kunooz is the overall holding company which holds these subsidiaries together. The five pointed stars in the design also depict the five subsidiaries and reflect the high standards which each subsidiary aims to set in its field of activity. The Green colour in the logo has been derived from the precious stone emerald. This links to the treasure in the company's name and also to the fact that the landscape of Dhofar is primarily green. Green also stands for growth which is imperative to make the company a successful one.

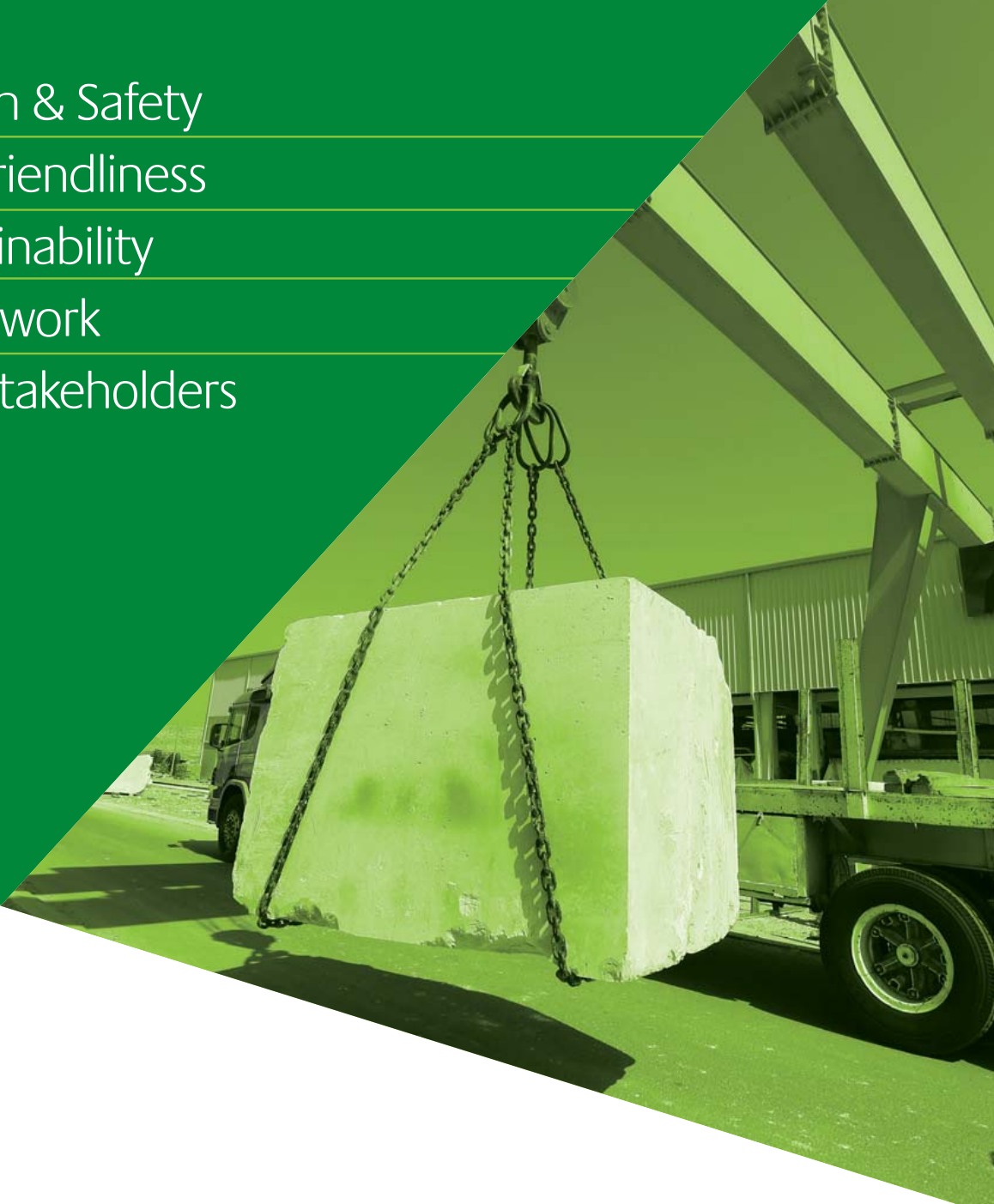

GYPSUM

Al Rawas Mining LLC (ARM) is based in Salalah and has been granted mining leases for searching, quarrying, excavating, transport and marketing of gypsum. The first mining lease was obtained in 2007 with the first shipment delivered in January 2011. Gypsum ore is extracted by the opencast mining method. The company exports its sized products to customers in the construction, cement, glass and fertilizer sectors located in India, Africa, Qatar, UAE, Bangladesh and Japan. The construction sector is the main end-user of gypsum, primarily for the production of plaster of Paris and plaster boards. Prospects for the construction sector over the next few years are encouraging with the anticipated high growth in urbanisation and infrastructure development in India, Africa and the GCC.

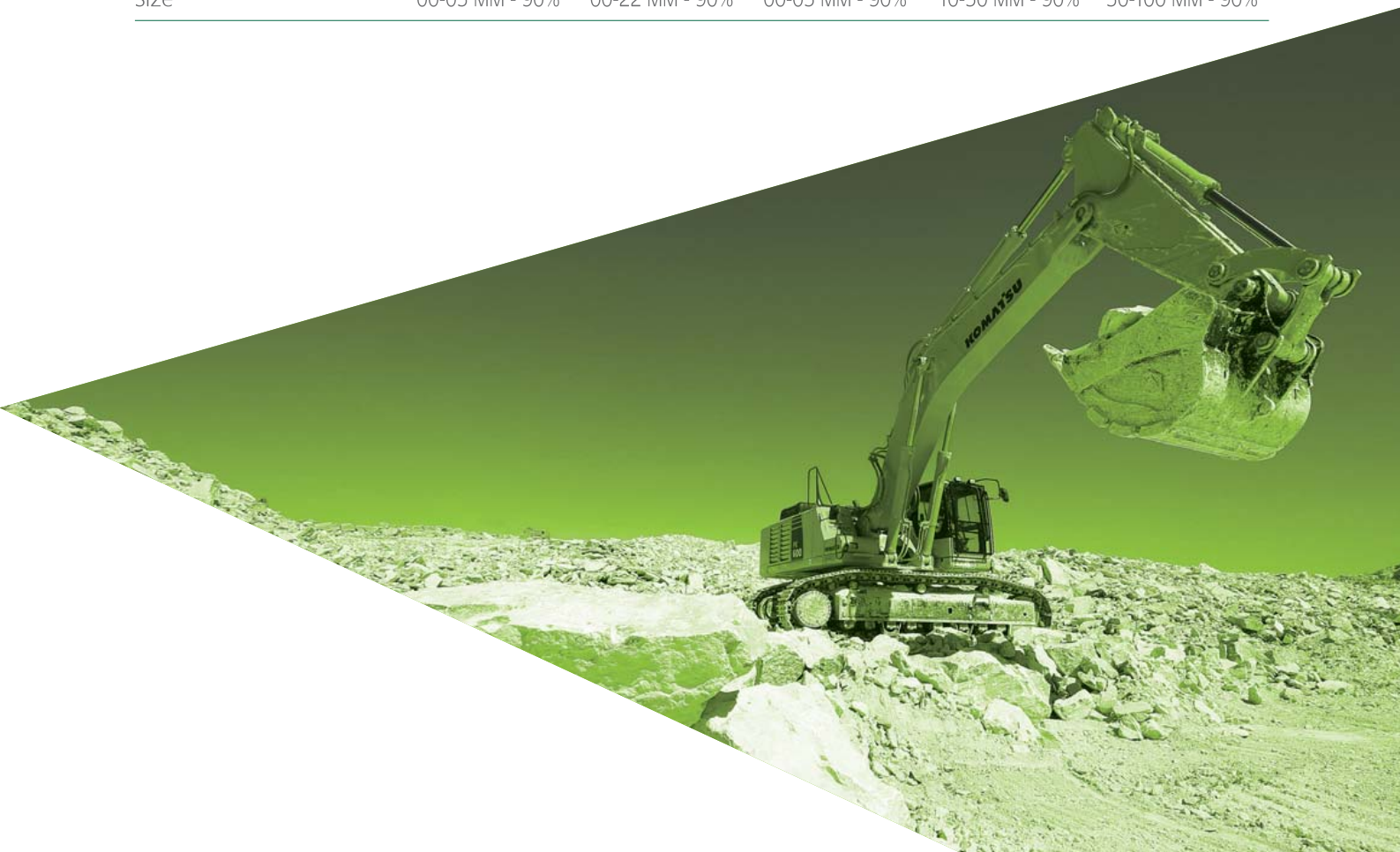

READY MIX CONCRETE

Salalah Ready Mix LLC (SRM) is a wholly owned subsidiary of Kunooz Oman Holding. It started its operations in November 2007 and is engaged in the manufacture of crushed stone and washed sand for the production of Ready Mix Concrete (RMC), blocks, curbstones, and other industrial applications. It is the second largest supplier of Ready Mix Concrete products in the Dhofar region.

In order to maintain a high quality product, its batching plant has a laboratory that systematically tests each batch of RMC prepared for customers and for the production of blocks and curbstones. The 3 batching plants are spread across the Dhofar region and can cater to projects of any size.

GABBRO

Mihwar Al Wifaq is engaged in the quarry and crushing business situated in Jifneen, Willayat Seeb. The company was allotted a mining lease for a gabbro quarry in 2003 and actual mining activities commenced in 2012, followed by commercial operations that commenced in May 2013. The material quarried consists of a high quality gabbro, which is crushed, screened and graded on-site with a 3-stage crushing plant. The company is ideally positioned to offer its products within the greater Muscat area. The products were certified to be used in wear coarse asphaltting at the Muscat International Airport project. Aggregates and crushed sand are also supplied to major ready mix companies which in turn supply it to infrastructure projects.

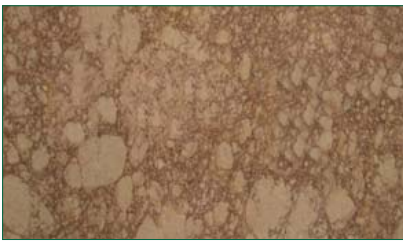

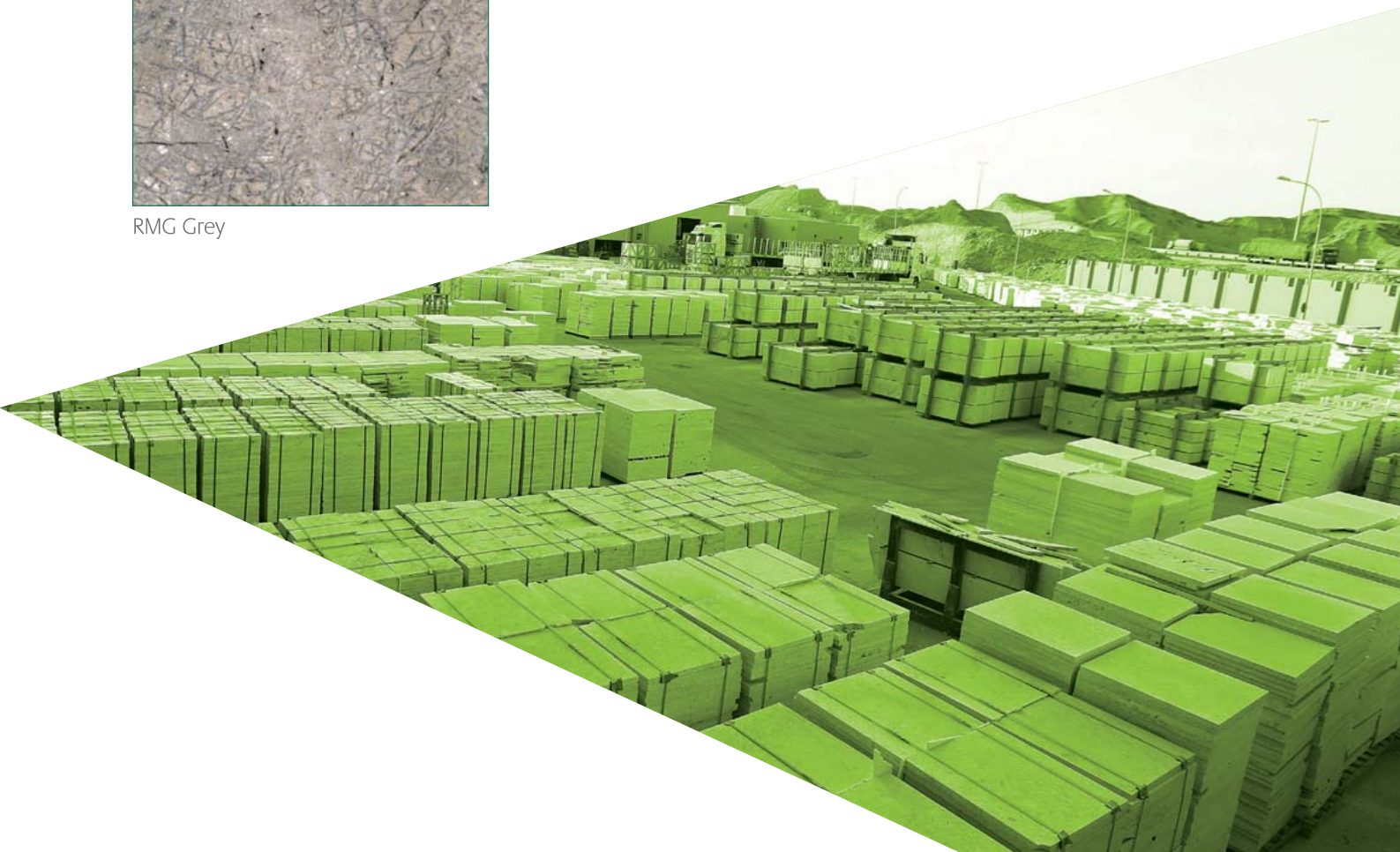
